2. The objects of the trust are :
  - (a) To establish, run and continue a School / College for the Education of S.C./ST/Orphans other Boys & Girls & Technology (Engineering) Environment studies in Arts, Science, and Hindu Religion and Culture of the Aryan Cult and to develop their character as well as to educate them in physical culture, (1) Helping poor children by sponsoring them for higher education. (2) Sponsoring visits of school-children selected from various schools (3) By providing school uniforms, books, fee etc. (4) Vocational training, free-coaching for various courses.(5)Old age home (6)Shelter for homeless children.(7) Medical facility for poor/rural people.(8) Plantation. (9) Sports and (10) To render help and assistance to victims of natural calamities.

These accounts and the balance sheet shall be duly audited and examined by a Chartered Accountant, which may be engaged by the Board of Trustees for purpose of such audit on such remuneration, as they may deem necessary and desirable. - (ii) The Trustees shall engage and employ such teaching clerical and menial staff for imparting education, maintaining Office, cleaning the premises and other acts essential for the purpose. Such staff will be paid such salaries as the Trustees may decide.
- (iii) The Trustees may invest the surplus funds of the Trust in their hands accrued from the income from property of trust or otherwise by donations etc. in Governments securities or fixed deposits in the State Bank of India or other Scheduled and Nationalised Banks as found convenient to them.

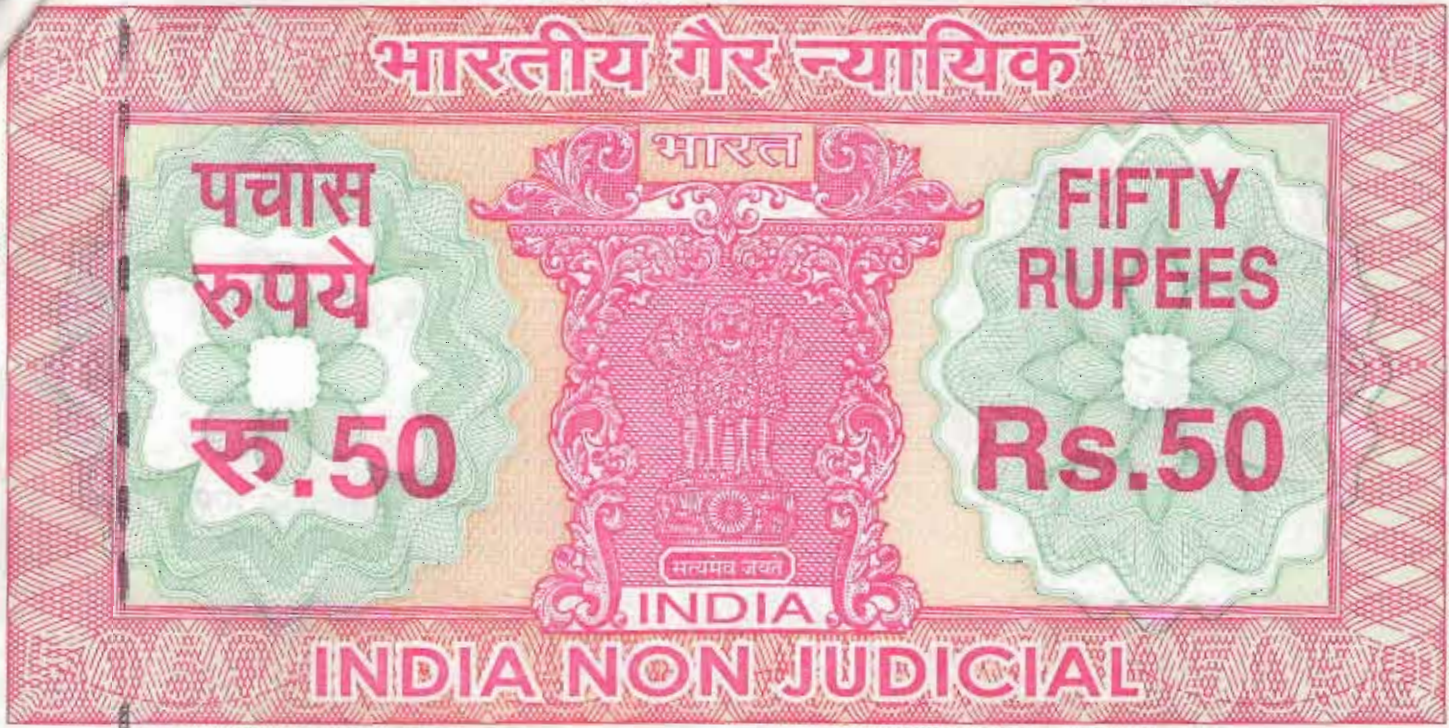
